
Review of the Principles of Collective Impact and its importance to the Nursing Community





Attendees discussed the refined MN Nursing Community Policy Forum Principles and talked about next steps.

- 1. Minnesotans should have access to affordable high-quality healthcare.
- 2. Addressing mental health and suicide prevention are crucial to the wellbeing of Minnesotans and our state.
- 3. Access to high quality healthcare should be supported and improved for Minnesotans living in rural communities.
- 4. All students should have access to on-site school health services.
- 5. Minnesota should address gun safety and prevention of gun violence as public health issues.
- 6. Healthcare workers should be able to practice in setting that are safe and free from violence.

These Principles have been supported by the boards of directors of the following organizations as of 1/16/2020:

Next, attendees discussed the NursingNow global principles, that seek to raise the profile of nursing throughout the world

- 1. Establish more nurse-led clinics, enabling nurses and midwives to work to their full potential.
- 2. Employ more specialist nurses in all areas of care.
- 3. Make comprehensive midwifery services available everywhere, offering a full range of maternal and newborn health care.
- 4. Make nurses central to primary health care providing services and supervising community health workers
- 5. Support nurses and midwives to deliver health promotion and disease prevention.

Our discussion about how these principles might apply to Minnesota focused on Goals 1 & 4, with their emphasis on nurse-led clinics and primary care. The comment was made that we need to ensure that nurses are central to primary care.

Participants were encouraged to bring these Goals back to their organizations to begin discussions. We will discuss at the next Nursing Community Policy Forum meeting.

Legislative Scanning for the 2020 MN Legislative Session:

Issues for the 2020 Legislative Session:

• MN APRN Coalition:

SF 1966, authors Kiffmeyer, Marty, Eaton, Abeler, Rosen; HF 1914, authors Edelson, Pierson, Albright, Bahner. APRNs added to certain statutes. Discusses as a clean-up bill to have consistency with current practice. Adds APRN signature in multiple sections (125 pages). Does not expand scope. No fiscal note. This addresses statutes only, will work on rules in the future.

• MNA:

Workplace Violence Prevention: may try to add language to the 2015 Bill

• SNOM:

Medication destruction bill: SF 247, authors Pratt, Clausen, Rosen, B. Anderson. HF 575, authors Huot, Haley Erickson Morrison, Davnie. Unclaimed drugs or mediations in schools disposal provided. No fiscal note, has bipartisan support. Does not include controlled substances. Will go as a stand-alone. SNOM noted that over 1/3 of the schools in the state have no school nurse, that there is no consistency in the state.
