- Identify and discuss legislative issues relevant to state wide nursing organizations that could benefit from a collective impact agenda.


COLLECTIVE IMPACT PRINCIPLES OF PRACTICE TACKLING COMPLEX PROBLEMS

- Design and implement the initiative with a priority placed on equity.
- Include community members in the collaborative.
- Recruit and co-create with cross-sector partners.
- Use data to continuously learn, adapt, and improve.
- Cultivate leaders with unique system leadership skills.
- Focus on program and system strategies.
- Build a culture that fosters relationships, trust, and respect across
 participants.
- Customize for local context.

ESSENTIAL Mind Shifts for Collective Impact¹

- Get all the right eyes on the problem
- The relational is as important as the rationale
- Pay attention to adaptive work and not just technical solutions

Discussion of video:

- Similar to the "Fist to Five" model of consensus "fist" means "I don't like it and I can't live with it" Five means "I love it"
- Importance of respectful process
- Challenge to keep process explicit
- One attendee said s/he will trial the Primes Consensus Model at a meeting 6/27/19

2019 Proposed Principles

- Minnesotans should have access to affordable high-quality health care.
- Access to high quality health care should be supported and improved for Minnesotans living in rural communities.
- All students should have access to adequate health care screening and on-site school health services.
- Minnesota citizens deserve to live free of gun violence.

Discussion of Principles and Issues for Organizations Considering Endorsing:

- Organizations that endorsed all or some of the principles:
 - SNOM -Adopted all principles
 - MNNP Adopted all principles
 - MNORN Adopted all principles
 - GTC-ENA Adopted principles 1-4
- Some may feel that the principle about gun violence was "political" and not about nursing. Others see gun violence as a serious public health nursing issue. Perhaps language more nuanced than "free of" could demonstrate the public health concern in a less "political' manner
- Several organizations really liked the focus on rural health (MOLN, NPs)
- GTC-ENA endorsed all principles except for gun violence
- SNOM request that gun violence be re-framed as a public health issue, not a "nursing" public health issue. They do not want gun violence to be dropped as a principle.
- Suggestion to add a 6th principle about mental health and suicide in MN rural, pediatric, healthcare providers

Followup from 2019 MN Legislative Session

Successes:

- Provider tax demonstrated the importance of building coalition around an important issue
- Regulations for memory care/assistive living
- Small grant for domestic violence

Challenges:

• APRN bill pulled by Senate author without explanation

- APRNs unsuccessful in their attempt to get an APRN on the Opioid Stewardship Council
- SNOM Bill re: disposal of medications was dropped prior to the end of session don't know why

Discussion:

- As a former legislator, Maria Ruud stressed the importance of coalition building. Be strategic use the members of the coalition's Representatives and Senators. Speak up. Be present. Use Voice.
- Educational opportunities:
 - MOLN's Public Policy Internship will be held November 5th and 6th
 - MOLN has gone to individual "Days on the Hill" like a series of mini-blitzes, voice of nursing will let Nursing Policy Forum members know when more are scheduled.

Emergency Insulin Bill

Background:

• Emergency Insulin Bill didn't make it into the final omnibus bill. Governor Walz has agreed to a special session only if the parties can come to agreement on a bill. Currently the Republican and Democrat approaches are wide apart.

Discussion:

- Insulin is a basic human need for those who cannot live multiple days without insulin
- Importance of reading out to legislators (especially Republicans) to urge consensus, reminding them that this is a critical, life & death issue for those who require insulin to manage their diabetes.
